

**Draft Minutes of the  
Town Forest Steering Committee Meeting  
5/9/18**

**Attendance:** The following individuals attended the meeting which was held at the Hartford Town Hall at 171 Bridge Street, White River Junction on Wednesday, May 9, 2018.

**Steering Committee Members:** Jon Bouton, Mary Hutchins, Tom Kahl, Allan McDougall, Sean Ogle, Lisa Philips and chair/facilitator Angie Emerson.

**Staff:** Planner Matt Osborn.

**Others:** None.

Chair Angie Emerson called the meeting to order at 6:04 p.m. Introductions were made.

**Steering Committee Minutes of January 23, 2018:** Angie Emerson asked if there are any corrections to the Minutes of January 23<sup>rd</sup>. There were none. The minutes were accepted as written.

**Trails Assessment:** Sean Ogle of the Upper Valley Trails Alliance reported that the Town has hired the Trails Alliance to undertake a trails assessment of all of the trails in the Town Forest. Work will begin soon and the project will be completed by the June 7<sup>th</sup> Steering Committee meeting. Matt Osborn asked if the problem areas will be georeferenced. Sean responded yes. The information will be included in G.I.S. files and maps.

Allan McDougall noted that hazard trees exist along some trails and we may want to cut them down to eliminate danger to recreationists. Sean Ogle responded that hazard trees will be documented during the trails assessment.

**Vision Framework and Draft Strategies Worksheet:** Angie Emerson stated that the purpose of the meeting is for the Steering Committee to review and comment on the Draft Vision Framework and Draft Strategies Worksheet. The Steering Committee proceeded to go through the draft.

**Management Balance/Public Workshop Survey:** Tom Kahl noted that the survey results under management balance don't seem to match the bar graph. Matt Osborn responded that it appears that the "more important" and "equally important" categories are combined.

**Survey and Workshop Visioning Input:** The Steering Committee reviewed the existing experience and future desired experience responses from the visioning workshop.

**Key Attributes:** The Steering Committee reviewed the key attributes and did not have any comments.

**Issues, Needs and Ideas:** Responding to the question, are there any issues, needs, or ideas we did not properly characterize, Matt Osborn suggested modifying the statement "no program in place for trail maintenance" to "need to establish a formal trail maintenance program". The Steering Committee agreed.

**Draft Strategies:** The Steering Committee reviewed the draft strategies. There was consensus that there is a distinction between a forest and a park and that the Town Forest should remain a forest and not a park. As a result, improvements should be limited.

The Steering Committee came up with revisions noted in slash-out/underlined. The Steering Committee also developed a recommendation and comments in the far right column. There are a few strategies that the Steering Committee felt needed further discussion. Those are identified with a “?” followed by “need further discussion”.
